All the selected papers shall be published in the conference proceedings volume. The best paper presented at the conference will be awarded an honorarium of Rs.7000. Authors of accepted papers may be requested to act as discussants for other papers.

We will be organizing a **Research Colloquium** on the day of the conference, for students of economics who are in early stages of their research. We encourage students working on their research proposals broadly based on the above themes to apply for the colloquium. We intend to accommodate limited number of papers in the sessions wherein students will receive feedback from senior researchers and also interact with other research students from various institutions.

Best research proposal will be awarded cash prize of Rs.5000.
